

The City of Lakeshire will hold a public hearing to discuss the allocation of \$20,000 in Community Development Block Grant Funds, which will become available after January 1, 2018. The public hearing will be held at 6:30 P.M. on June 12, 2017, at Lakeshire City Hall, 10000 Puttington Drive, Lakeshire, MO 63123. To further its commitment to fair and equitable treatment of all citizens, the City of Lakeshire has enacted and/or enforces the following:

- A Fair Housing Ordinance prohibiting unlawful discrimination against any person because of race, sex, color, religion, disability, familial status or national origin;
- A Policy of Nondiscrimination on the Basis of Disability in the admission or access to, or employment in, its federally assisted programs or activities;
- A Policy of Equal Opportunity to Participate in Municipal Programs and Services regardless of race, color, religion, sex, age, disability, familial status, national origin, or political affiliation;

Suddenly there will be a chill in the air as the temperature drops during the dog days of summer. Birds will flee to nests and mammals to the refuge of their dens. Insects, reptiles, and nocturnal animals will emerge from their daytime hiding place. Bright stars and planets will appear in the daytime sky.

The date is August 21, 2017 and the world is not coming to an end. Lakeshire, like part of the country and metro area is on the narrow path of a total solar eclipse not experienced in this region for nearly 500 years. People from all over the United States and around the world will be in our part of the planet to experience this phenomena.

A partial eclipse will begin in the sky over our community on Monday August 21st at 11:49 A.M. as the moon comes between the earth and sun. Total darkness will occur at 1:17 PM and last 1 minute, 35 seconds. Then we will experience the second dawn of the same day. For a wealth of information, enter "2017 Total Eclipse" in your computer search engine. Most importantly, while viewing the partial portion of the eclipse be sure to protect your eyes with solar filter glasses (sunglasses do not give protection).

Emergency Managers plan for natural and manmade disasters. In this case, we are planning for an event of "misperception". Despite months and weeks of media attention leading up to the eclipse, there are those among us who unknowingly will be alarmed and frightened. The emergency 911 system is likely to be overwhelmed. City Hall and Police Administration phones will echo a busy signal. Medical and other emergencies will likely result from overreaction and confusion.

Lakeshire police like other first responders in the path of the eclipse are planning and preparing to deal with public safety issues resulting from this event. Despite some unusual challenges the forces of good will triumph over evil. So, fear not and on August 21st relish this once in a lifetime opportunity.

Lakeshire Trash Guidelines

<u>Appliances:</u> 2 items per week at \$28.00 per item Can be charged to the account. Must be at the curb. Must be scheduled by 5pm the business day before pick-up. Currently picked up on Monday.

<u>Bulk:</u> 2 Item limit per month at No Charge. Picked up on the customers last pick up day of the month.

<u>Construction Debris:</u> Minimum charge of \$50.00-\$75.00 per pick-up truck load. No more than 2 standard size truck loads per pick up. Must be curbside and will be picked up on trash day.

<u>E-waste:</u> Televisions & CRT Monitors: \$75.00 per item. Any Other Electronics: \$25.00 per item Non-Negotiable. Must be Scheduled by 5pm the business day before. Must be at the curb. Currently picked up on Monday.

GARAGE AND ESTATE SALE PERMITS

The Board of Aldermen has voted to raise the cost of Garage sale and Estate sale permits to \$5.00 for 1 or 2 consecutive day sale and \$10.00 for 2 non-consecutive dates. There is still a limit of 2 garage

sale permits per year per address. This increase will go into effect as of July 1, 2017. This is the only increase the city has had with these permits

COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

The City participates in the St. Louis County's Community Development Block Grant Program which is funded through the United States Department of Housing and Urban Development. After January 1, 2017, \$20,000 will again become available for use by eligible, low to moderate income individuals and/or families. Those who meet the eligibility requirements can apply for funds (not to exceed \$5,000) to be used for major items, such as roof, furnace, air conditioner repairs/replacement, foundation work, etc. The program permits a one-time participation per homeowner.

The CDBG Specialist for the South County area is Alex Devlin and he can be reached at 314-615-8236. The County will determine if you are eligible for participation and can provide more details about the program and the application process.
