APRIL 2, 2019 MUNICIPAL ELECTIONS

Filing for the April 2, 2019 Municipal Election will open at 8:00 a.m. on Tuesday, December 11, 2017. You may file at City Hall on opening day between the hours of 8:00 a.m. and 10:00 a.m. After opening day, you may call the City Clerk at 314-638-4347 between 7:00 p.m. and 9:00 p.m. to set up an appointment to file. Filing will close at 5:00 p.m. on Tuesday, January 15, 2019. Candidates may file for a two-year term for the following positions: ALDERMAN WARD I, ALDERMAN WARD II and ALDERMAN WARD III and for a one-year term for ALDERMAN WARD III to finish out the term of Alderman Sherod.

Candidates must have the following qualifications:

- Must be at least 18 years old to run for Alderman.
- Must be a registered voter.
- Must be a resident of the City of Lakeshire for one year.
- Must have lived in your Ward for at least 90 days prior to the election, and shall not be in arrears of any city taxes or municipal user fees on the last day to file a Declaration of Candidacy for the Office.

If someone calls you stating they are from one of these agencies, hang up on them immediately. Don't carry on a conversation with them. They are experts at scaring you into sending them money.

ANNUAL REMINDER: When the weather person on TV or radio predicts inclement weather, such as snow and ice, please park our vehicles in your garages and driveways and NOT on the streets. This will allow for the snow plows to clean the streets more efficiently.

If you are traveling during the holidays, please do not forget to fill out and turn in your vacation check forms. We will personally check your residence at least three times a day.

COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

The City participates in the St. Louis County's Community Development Block Grant Program (CDBG) which is funded through the United States Department of Housing and Urban Development. After January 1, 2019, \$20,000 will again become available for use by eligible, low to moderate income individuals and/or families. Those who meet the eligibility requirements can apply for funds (not to exceed \$5,000) to be used for major items, such as roof, furnace, air conditioner repairs/replacement, foundation work, etc. The program permits a one-time participation per homeowner.

The CDBG Specialist for the South County area is Alexandra Durdello and she can be reached at 314-615-8236. The County will determine if you are eligible for participation and Alexandra can provide more details about the program and the application process.
