**AN ORDINANCE OF THE CITY OF LAKESHIRE, MISSOURI LEVYING AND ESTABLISHING THE TAX RATE IN THE CITY OF LAKESHIRE, MISSOURI, FOR THE YEAR 2018 ON ALL PROPERTY SUBJECT TO TAXATION IN SAID CITY OR FOR GENERAL MUNICIPAL PURPOSES PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION AT A RATE OF 0.375 ON ALL RESIDENTIAL REAL ESTATE AND A RATE OF 0.375 ON ALL COMMERCIAL REAL ESTATE.**
