City Clerk's Report as posted on the bulletin board: Jill Feltmann made the correction of bill and ordinance numbers to Bill 14 and Ordinance 1053 for the amended purchasing code. A motion was made by Alderman Bilzing to approve the minutes of the October 14, 2019 Board meeting with this correction. The motion was seconded by Alderman Zumwalt. The motion carried.

Treasurer's Report: A motion was made by Alderman Bilzing to accept the Treasurer's report for the month of October 2019 as written and checks #31208 through #31292 from the General Account plus three EFTPS payroll deposits. The motion was seconded by Alderman Twellman. The motion carried.

Building Commissioner's Report: A motion was made by Alderman Zumwalt to accept the Building Commissioner's report for the month of October 2019 as written. The motion was seconded by Alderman Twellman. The motion carried.

He will contact the property owner to have the broken branch removed before it does damage. Old Business

A. Discussion and Ordinance for curbing on Lakeside Drive. Two bids were received for the exact same specks. One from Pioneer Paving and Sealing Company and one from CEG and Family Paving and Sealing, LLC. The bid from Pioneer Paving was for \$3,928.00. The bid from CEG Paving was \$4,158.00. A motion was made by Alderman Bilzing to accept the bid from Pioneer Paving and Sealing Company because it was the lowest price and that they have done previous work within the city. - B. Discussion of renewal of Subscriber Radio Contract. Tabled until the December meeting.
- C. Discussion and possible ordinance for change in open burning. The city already uses the County codes, so no ordinance will be needed.
- D. Discussion of medical marijuana. Tabled until the December meeting.
- E. Discussion of proposed health insurance and 401K for full-time officers. A presentation by Mike Butz from Crawford and Butz Insurance for medical insurance. A master Chamber of Commerce plan was proposed. The plan must have a minimum of two officers insured to begin and maintain the plan. Dental and vision will be an extra premium. The rates will be frozen until June 2021. Still waiting for actual figures to come in. Wally Schmeider was unable to attend the meeting, so Mike Butz gave a general overview of the proposed 401K Safe Harbor plan. The city can choose whether to pay three to five percent of the fulltime officer's salary and the officer could put in whatever amount they wished up to fifteen percent of their salary. No decision was made at this meeting on either plan.
- F. Discussion of 2020 Budget. Proposed budget was distributed to the Aldermen and discussed. Bud Funk will re-evaluate the numbers and present new proposed budget at the December meeting.

Residents' Comments:

Mayor Seher presented a follow up to the mosquito spraying. If a resident wishes to opt out of mosquito spraying, there would be no spraying on that entire street. No decision was made either way, but it was noted that the city has already signed the usual five-year contract.

Mayor Seher announced that Alderman Twellman is resigning his position due to the fact that he is moving out of the city. He thanked Alderman Twellman for his three years' service to the city and stated that he will be missed.

Adjournment: A motion was made by Alderman Bilzing to adjourn the General session at 8:50 p.m. The motion was seconded by Alderman Cowan. The motion carried.
