**Discussion of 2023 Tax Rate:** Mayor Pro Tem Bilzing read the information regarding the 2023 tax rate for the City of Lakeshire which has been posted.

**AN ORDINANCE OF THE CITY OF LAKESHIRE, MISSOURI LEVYING AND ESTABLISHING THE TAX RATE IN THE CITY OF LAKESHIRE, MISSOURI, FOR THE YEAR 2023 ON ALL PROPERTY SUBJECT TO TAXATION IN SAID CITY FOR GENERAL MUNICIPAL PURPOSES PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION AT A RATE OF \$0.2770 ON ALL RESIDENTIAL REAL ESTATE AND \$0.3360 ON ALL COMMERCIAL REAL ESTATE.**


Having received five affirmative votes, Ordinance No. 1121 was approved.
